7-1-7 CLASSIFICATIONS OF OFFENSES AND SENTENCES

A. OFFENSES ARE DESIGNATED AS A CLASS A, CLASS B, AND CLASS C. OFFENSES WITH MAXIMUM FINES AND IMPRISONMENT AS FOLLOWS

CLASS A: FINE NOT TO EXCEED \$5,000 AND A TERM OF IMPRISONMENT NOT TO EXCEED 1 YEAR

CLASS B: FINE NOT TO EXCEED \$1,000 AND A TERM OF IMPRISONMENT NOT TO EXCEED 6 MONTHS

CLASS C: FINE NOT TO EXCEED \$200 AND A TERM OF IMPRISONMENT NOT TO EXCEED 1 MONTH

B. ANY OFFENSES FOR WHICH ON PENALTY OF SENTENCE IS SPECIFIC OR WHICH IS NOT SPECIFICALLY DESIGNATED A CLASS OF OFFENSE; SHALL BE TREATED, FOR THE PURPOSE OF IMPOSING PUNISHMENT, AS A CLASS C OFFENSE.

NOTE: AS OF AUGUST 1987 - ANY PREVIOUS D.U.I.'S PRIOR TO THIS DATE, ARE NOT ADMISSIBLE IN COURT.

STANDARD 1ST OFFENSE D.U.I. SENTENCE

\$1,000.00 FINE, \$300.00 SUSPENDED FOR D.U.I. SCHOOL; 30 DAYS INCARCERATION (SUSPENDED) FOR AN ALCOHOL AND DRUG ASSESSMENT AND FOLLOW RECOMMENDATIONS MADE BY N.C. RECOVERY PROGRAM. DRIVING PRIVILEGES ARE SUSPENDED FOR 90 DAYS.

STANDARD 2ND OFFENSE D.U.I. SENTENCE

\$2,000.00 FINE, + 60 DAYS INCARCERATION + DRIVING PRIVILEGES ARE SUSPENDED FOR 180 DAYS

THIRD OFFENSE D.U.I. SENTENCE

\$5,000.00 FINE AND 1 YEAR INCARCERATION (HABITUAL OFFENDER 3RD CONVICTION WITHIN 2 YEARS).
