## **Renters' Rights:**

As a renter, you have rights and responsibilities which protect you and your landlord from violating housing laws. It's the roof over your head, and you need to know how to take action when things don't seem fair.

## Can I sign a rental agreement if I am under the age of 18?

Yes, but many landlords will not rent to you if you're under 18 because you can't legally be held to a contract. You may need a court order of emancipation to remedy that.

### What do you do if you are served with eviction court papers in Montana?

- 1. Read the court paperwork and figure out your deadline to answer.
- 2. Contact MLSA. We can walk you through the basic process:
- Download, print, or fill out online the free court forms found on <u>MontanaLawHelp.org</u> to file an answer to the lawsuit.
- File the answer with the Clerk of Court and mail a copy to your landlord.
- Attend all hearings and mediation (if ordered).

# What housing protections exist for survivors of domestic violence, dating violence, sexual assault, and/or stalking?

<u>Federal law</u> offers housing protections to survivors. These protections include:

- Cannot be denied admission to federallysubsidized housing because of violence committed in the space
- Cannot be evicted or have assistance terminated Learn more at <u>MontanaLawHelp.org</u>

#### Are the rules the same for all rentals?

- 3. Renters in tribal communities.
